

## Participation Agreement

To create a safe environment for all participants in the Tantric Holiday course, and to clarify the rules for payment and changes, the following are established.

### Terms and Conditions of Participation:

1. Participation in the course is open to adults of legal age and capacity only.
2. The participant is responsible for his/her own actions and conduct, including his/her actions towards other persons at the course location.
3. Everyone participates in each event and individual exercises on a completely voluntary basis, and their own free decisions. The participant has the right not to participate in the exercise and at the same time to inform the instructors in advance.
4. Participants and the organisers and trainers shall not to disclose personal data or other confidential information that they obtain during the course to third parties.
5. Participants shall refrain from taking any visual or audio recordings of the course without the express permission of the instructors and also of the recorded/photographed persons.
6. Participants who intend to write or otherwise publish the course events shall warrant that he/she will only do so with the written consent of the organisers.
7. This course does not represent psychotherapeutic or other medical care.
8. Some events/exercises may be physically or psychologically demanding for some participants. The participant is required to notify the instructors of any psychiatric treatment and outpatient treatment and whether he/she is using or has recently used psychotropic substances or psycho pharmaceuticals. The trainers shall maintain the confidentiality of such disclosures facts.
9. The participant shall inform the organiser and the lecturers if his/her health condition deteriorates or otherwise changes in a negative direction during the course.
10. Participation in the course is prohibited for persons with infectious diseases. The participant shall respect the general health and hygiene rules as well as the organisational rules set by the organiser and the lecturers.
11. In the event of injury or illness during the course, each participant is responsible for his/her own costs, financial costs of medical treatment and care.
12. Participants are responsible for their personal belongings and valuables.
13. Neither the organisers nor the tutors shall be liable to the participant for any injury, loss or damages.
14. Participants agree to abstain from excessive use of alcohol, illicit drugs and

narcotics, as well as damaging the equipment of the course venue. By submitting an application, the participant expressly agrees to the above Terms and Conditions of Participation.

### **Payment and Cancellation Policy:**

Registration for the event is valid after payment of the deposit of € 500 within 3 days of confirmation for a person.

The organizer will provide you with an account number upon confirmation of the application.

The payment of the balance is due to the same account by July 31, 2022.

The price includes:

- 30 hours (5 hours per day)
- Accommodation for the duration of the course in Villa Gaia, Seggiano, Italy
- Vegetarian meals half board during the course (starts with dinner on day 1, ends with breakfast on the last day)
- Interpretation from Czech to English.

In case of withdrawal from the event after payment of the deposit, the deposit will be forfeited.

The deposit can be transferred to another participant (of the same sex).

If the participant decides to terminate his/her participation in the course, the amount paid will not be refunded.

### **Privacy Policy:**

The organisers and the lecturers ensure the protection of the personal data collected for each participant in 101/2000 Coll. The processing of his/her personal data by the organiser or the entities providing the services to the Organiser necessary for the performance of its activities. The Organiser will not provide them to any other party, unless provided for by law. Each participant has the right to ask the Organiser to have their personal data removed from processing after the end of the course. Participants agree to receive organizational and commercial communications from the Organizer.
